The amount of the required deposit is based on the number of guests expected at the event.

<u>Number of Guests</u>	<u>Deposit Required</u>
30 or less	\$ 30.00
31 to 50	\$ 50.00
51 to 75	\$ 75.00
76 to maximum of 100	\$100.00

Deposits will be refunded according to compliance with the Park Rules and the following Pavilion Rules.

PAVILION RULES AND REGULATIONS

1. No vehicles are allowed on the Park land or the Pavilion.
2. If moved, picnic tables must be replaced in original locations.
3. All trash must be picked up, bagged, and placed in the trash receptacles provided.
4. No loud music or noise that would disturb neighbors is allowed.
5. Bathrooms must be left in a tidy and orderly condition.
6. Other park facilities must be shared with District residents and are not available for reservation.
7. No space walks, rides, or other playground equipment may be brought into the Park or Pavilion.

The District reserves the right to impose additional restrictions on use as the situation warrants.

ACCESS POLICY

RULES AND REGULATIONS

Please, **NO**:

1. Destructive activities.
2. Discharge of a firearm, pellet gun, bow & arrow, sling shot or other hazardous item.
3. Glass containers.
4. Unleashed pets.
5. Fireworks.
6. Disorderly conduct.
7. Motor driven vehicles or equipment.
8. Use of controlled substances or public consumption of alcoholic beverages; however, alcohol is permitted in the Park Pavilion when it is reserved for private functions.
9. Camping.

The District reserves the right to impose additional restrictions on use as the situation warrants. Any person violating these rules may be subject to penalties up to \$200 per occurrence.
